

NCsoft San Diego 2011 Meet & Greet Party Raffle Contest Official Rules and Conditions

This contest is organized by NC Interactive, Inc. who is identified in more detail in Section 9 of this document (the "***Sponsor***").

1. ENTRY

NO PURCHASE NECESSARY. IF YOU ARE ENTERING THIS CONTEST AS A RESIDENT OF THE UNITED STATES OF AMERICA THIS CONTEST SHALL BE VOID WHERE PROHIBITED BY UNITED STATES LAW.

This is a free prize draw (the "***Contest***") and you are not required to buy any product, or service from the Sponsor, or to be a subscriber to any of the Sponsor's games to enter the Contest.

Participants must follow this method of entry:

1) Accept a physical raffle ticket in person upon arrival at the *NCsoft® San Diego Meet & Greet, in San Diego, California at the Hard Rock Hotel on Friday, July 22, 2011* (the "Event") between 5:00 and 8:00 pm PST. This ticket is considered your "entry."

By submitting an entry to the Contest, you accept and agree to be bound by these Official Rules and Conditions.

Any personal information given to the Sponsor when you enter this Contest will only be used to contact you in relation to this Contest. All information concerning non-winning entries will be discarded after the end of the Contest. The personal information concerning the winning entries will be only used in the context of this Contest and use of your entry as agreed between you and the Sponsor. The Sponsor is not responsible for lost, late, incomplete, incorrect, unintelligible or misdirected entries, which will be void. Sponsor, in its sole discretion, can disqualify, from this Contest and/or any other contest conducted by Sponsor, any person who, in Sponsor's reasonable suspicion, tampers with the entry process.
